Transmission Events. An Ontario spin studio, also known as an indoor cycling gym, has seen an outbreak which lead to 61 positive COVID-19 cases and was reportedly following all public health protocols. These include screening of staff and members, keeping track of individuals in classes, masking before and after the class, and cleaning towels and rooms within 30 minutes of a class. Furthermore, the facility was operating at 50% capacity and had the equipment distanced six feet away. Health officials have advised that the protocols in place will be reviewed, as the area was not considered a hot spot and the facility was following all the guidelines. 44 of the members have been infected, as well as at least 17 secondary cases which were contacts exposed by members of the gym. Additionally, patient zero is believed to have been asymptomatic. Such a large outbreak occurring even with all protocols in place suggests that the policies themselves may not be enough, and will need to be tweaked as we learn more about the virus and its transmission. No information was provided regarding the ventilation system for the gym; however, this outbreak may be evidence of airborne transmission of COVID-19, suggesting it may stay in the air for long periods of time, and does not always fall to the ground right away. Exercise classes involve heavy inhalation and exhalation, activities which are more likely to increase the amount of the virus which is expelled via heavy breathing. Similarly, a choir practice infected 87% of the singers in Washington, and it is likely that even in large rooms, despite staying 6 feet apart, activities which heavily expel the virus such as singing, yelling and working out, are high risk for transmission. As such, it is believed that should these types of exposure events continue, public health measures will be changed to avoid this type of high-risk activities from becoming superspreader events. Impacts of closing down gyms and exercise studios will be felt by both the owners and staff of such gyms, who will be impacted financially, as well as for individuals who are looking to exercise and keep fit.

Reinfection of COVID-19. There are currently 23 known global cases of COVID-19 reinfection found in Qatar, India, Netherlands, USA, and China. Reinfection occurs when a positive person finally tests negative for the virus, and subsequently again tests positive. It is important to note that people may test positive for COVID-19 even after being infectious or sick, and that some of the reinfection may be due to false negatives, making it appear that the person had tested negative but was actually still positive for the virus. Most individuals who test positive again appear to have a more serious second infection, a worrying trend. Some appear to have been re-infected with a strain that is different than the first, raising questions on COVID-19 immunity for long periods of time. Recently, Dutch officials have reported the first death occurring from re-infection of COVID-19, in an 89-year-old woman that suffered from bone marrow cancer which compromised her immune system. 59 days after she was released from the hospital from the first bout of illness, and two days after beginning her chemotherapy treatment, she was again positive for COVID-19. No antibodies were found in her blood when she was tested during the second bout, and the patient later died. Although the patient did not have a negative test in between the two rounds, the genetic makeup of the viruses was found to be different and the researchers stated that it is likely the second bout was a reinfection and not an episode of prolonged shedding.

This month, the USA reported its first reinfection in a 25-year-old male. The male tested positive in April and June, and displayed some symptoms. The second episode was more severe and caused the male, who had no pre-existing conditions, to require oxygen at the hospital. Researchers found an antibody response after the second episode, but it is unclear whether the first episode caused any response and if so, for how long. This may suggest that a previous infection does not provide protection against a future infection, and health officials advise that those who have recovered from COVID-19 continue to follow public health measures to the same degree as those





who have not yet been exposed. August saw the first global report of re-infection, with a Hong Kong male testing positive 142 days after the first episode. This male did not experience a more severe second episode and instead was asymptomatic. It is possible that this individual may have been re-infected with the same strain, with some of his immunity from the first bout providing him with protection against the strain. Health experts are deciphering whether reinfection with the same strain or a different strain will have different effects, which will have implications on vaccine development and response effects.


Long-term COVID-19 symptoms. A rare set of individuals are reporting long-term COVID-19 symptoms, which is affecting breathing, heart and cardiovascular system, kidneys, liver and skin. These have been found in some individuals who were able to manage their illness at home, as well as those who were hospitalized. Some who have been intubated have appeared to heal completely, suggesting that this is not necessarily related to the severity of the illness. These individuals do not continue to test positive for COVID-19, yet still display symptoms which appear to come and go, suggesting that it is not a reinfection but a relapse in symptoms. Researchers believe that this may be attributed to four different syndromes: permanent damage to the organs post COVID-19, postintensive-care syndrome (PICS), post-viral fatigue syndrome, or a continuation of COVID-19 symptoms. PICS is known as an umbrella term for conditions commonly seen in patients who survived a critical illness or intensive care in the hospital, such as physical, cognitive and psychiatric impairments. This theory does not stand for individuals who have had a very mild illness who did not undergo hospitalization. Post-viral fatigue syndrome is also referred to as chronic fatigue syndrome, or myalgic encephalomyelitis. This causes fatiguing symptoms after physical or mental activity and making it difficult for patients to complete tasks which they were able to do before. This has been found to occur for some individuals after a viral or bacterial infection. The most feared scenario, that the symptoms are a continuation of COVID-19, would suggest that the virus may stay in the body for longer than anticipated. Researchers have not yet been able to provide evidence for this theory. With such a large number of individuals being infected with the virus at once, it is more likely that we will see more cases of individuals requiring long-term care due to COVID-19.


Europea. European countries are experiencing a second wave of the pandemic, with 27 countries of the European Union recording 78,000 new cases in one day; while the US reported 49,000 during the same time period. While the US is seeing 150 cases for every million citizens, Europe is at 152 cases per million citizens. Deaths are still lower than in the USA; although as a lagging metric they may increase in the upcoming weeks. France is imposing night curfews for four weeks in its major cities, including Paris, which will affect approximately 67 million people, to stop private parties and gatherings at night. Spain closed bars and restaurants for 15 days and limited the amount of people allowed in stores. Germany and London are reportedly going to impose new restrictions in the coming days, despite Germany already shutting down bars and pubs or shutting them down early. Governments are now looking into extending the winter break for students. It appears that most regions are keeping schools open while closing other less essential parts of the economy. Reactive measures are often less effective than proactive measures. With the exponential growth being seen in various jurisdictions, it is too late to impose lax measures and more strict measures will need to be put in place in order to reduce the number of individuals that are infected as well as the effects on hospitalizations and deaths.


